BUSINESS CHALLENGES

- > Multiple disparate financial systems
 - > Four (4) countries and twenty-five (25) legal entities
 - > Each county and company had its own financial system, industry application, and general ledger
 - ➤ Heavy IT support cost for infrastructure, licensing, and integration of multiple financials applications systems
- > Difficulty in producing timely and accurate regulatory reporting
 - ➤ High volume of financial transactions
 - > Every entity was reporting in a different way
 - > Each country has unique financial regulatory reporting requirements
 - > Difficulty comparing similar company by industry financial across countries
 - > Heavy dependence on information technology team to produce financial reports
- > Difficulty scaling financial systems to meet fast growth
 - ➤ Multiple acquisitions and start-ups





TARGET STATE DIAGRAM








INTERFACES DIAGRAM

- > Multi-national and multi-organizational Chart of Accounts Redesign and Finalization
- Integrations with Sub-ledger applications for trial balances to GL
- > Integrations with Bank and Bank Statements formats
- > Complex Group Consolidations and Financial Reporting requirements
 - > Over eighty plus (80+) International Financial Reporting Standards (IFRS) Financial Statements
 - > Multiple business lines with unique reporting requirements
 - > Multi-national regulatory requirements
- > Complete regulatory requirements change for Dominican Republic mid-system test
 - > Requiring a dynamic shift to accommodate the changes
- > Ongoing acquisition of new legal entities and divestures of legal entities throughout the project
- > Legacy Data Conversion Challenges
- > Change Management



CHANGE MANAGEMENT CHALLENGE



- Extensive training with detailed documentation and comprehensive user guides required
- Resources spread across five countries, multiple time zones, and languages
- Complexity of a multi-national, multi-industry implementation
- User resistance to change, lacking sense of urgency
- Massive financial process changes and switch cost
- Lack of process ownership in some areas
- Fear of failure and visibility to leadership
- Availability of resources to participate
